Good afternoon Mr. Gardner,

You will recall that you submitted a request under the Texas Public Information Act (TPIA) on July 19, 2018 for an unredacted copy of your personnel file. In response to such request, and in accordance with the TPIA, you were provided a full, unredacted copy of your personnel file. As you know, in the interest of public disclosure, the ATI has established a policy of posting on its website information it is required to disclose and information it elects to disclose responsive to TPIA requests. The ATI policy of posting documents on the website is voluntary and not required by the TPIA. With respect to disclosing documents, the TPIA only requires the ATI to provide responsive documents to the requestors requesting such documents, and even then, subject to applicable exceptions to disclosure under the TPIA. In accordance with the ATI's policy of posting documents, Ms. [REDACTED]'s information was redacted from the public posting because it contained what appeared to be her home address and personal cell-phone. The information regarding the other two referral sources included in your file were work addresses.
